The candidature of the shortlisted candidate is PROVISIONAL and subject to him / her qualifying in the Written Test and his / her eligibility in all respects as prescribed in the Advertisement and Recruitment Rules. The candidate would be required to produce his / her latest original certificates / documents in support of his / her claim relating to age, educational qualifications, category etc., during verification of their documents.

6. **The Written Test shall be conducted on 06/02/2022 at 10:00 AM, Itanagar.** Other details pertaining to the timing etc. of the written test shall be intimated separately. **Verification of documents shall also be done on the same day at 09:00 AM.** Hence, the candidate is also requested to bring all original documents and a copy thereof as mentioned in the original advertisement during verification of documents.

7. *Candidate must note that his / her candidature is purely provisional at this stage and his / her appointment will be subject to his / her name figuring in the provisional select list which shall be prepared after the Written Test & Document verification. Apart from that, he / she should fulfill the eligibility criteria as per Advertisement No.12/2021 Dated 10thDecember 2021, including possession of the requisite documents, failing which his / her candidature may be summarily rejected at any stage.*

8. *Further, the Appointing Authority i.e., the indenting / user department verifies the character & antecedents of the candidates, authenticity of documents / certificates and eligibility as per the Recruitment Rules before finally appointing the candidate(s). Therefore, the provisional shortlisting of a candidate does not confer upon him/her any right of appointment unless the Appointing Authority is satisfied, after such inquiry as may be considered necessary, that the candidate is suitable in all respects for appointment to the post.*
